Theta Edge Berhad Secures Telecommunications Infrastructure Contract Through Strategic Consortium

Awarded to a strategic consortium between TTSB and Harta Unity Sdn Bhd, the contract strengthens Theta's positioning in the fast-growing telecommunications infrastructure segment.
